





District 200 Approximate HIGH SCHOOL Student Partial & Full Vaccination Rates (Illinois Department of Public Health Database)







District 200 Approximate MIDDLE SCHOOL Student Partial & Full Vaccination Rates (Illinois Department of Public Health Database)



District 200 Approximate ELEMENTARY Student Partial & Full Vaccination Rates (Illinois Department of Public Health Database)






District 200 New Cases per Week



For example, if a school shows one new case on Tuesday and two new cases on Wednesday, that means there are two total new cases so far this week at that school.

Quarantine data fluctuates constantly, as students begin quarantine and return to school on various dates. The district will continue to report the highest number of the week for each school.

(Solid - ICU; Dashed - Non-ICU)




Zip Code Cases per 100,000 Residents



Ongoing COVID-19 Mitigations - CUSD 200



Isolation protocols for students who are COVID-19 positive or ill

Increased air changes (calibrated to room occupation and use of space)

MERV-13 filters in all univents, changed at regular intervals

Nightly ionization of air in all classroom spaces

Contact tracing and family notification for in-school close contacts

Test to Stay option for in-school close contacts

Investigation & additional mitigation protocol that exceeds public health requirements

Outbreak & Investigation



<u>Illinois Department of Health Definition</u>: Any three cases that are linked epidemiologically with respect to person, place (school building), and time (within 14 calendar days). This has not changed as case counts have risen exponentially.



<u>District 200 Investigation Protocol</u>: For each case of two overlapping cases within a single school, District 200 looks beyond close contact (physical distancing) and also analyzes other factors, including the implementation of mitigations, information from nurses' notes, and ventilation data, visiting individual classrooms if needed.

District 200 has investigated and documented detailed results for 1,857 instances of overlapping cases. Except for a very small number of cases detected by Test to Stay, none of the students were close contacts to each other in the school environment, and the majority have been found not to spend time in common spaces in the school environment. For cases where there was a shared school space, a deeper investigation is conducted.
