SUBJECT: FY23 Federal Relief Funding

There have been four different grant opportunities made possible through different legislation. District 200 developed six priorities for grant dollars.

- Priority 1: Activities to Allow for the Full-Time Return to School
- Priority 2: Learning Acceleration Programming
- Priority 3: Social Emotional Learning Supports
- Priority 4: Technology
- Priority 5: Curriculum Materials
- Priority 6: Facilities

ESSER I (CARES Act): This grant was authorized by the Coronovarius Aid Relief and Economic Security Act. The time period for funding was March 13, 2020 - September 30, 2022. CUSD 200 was allocated \$1,035,445. All funds have been encumbered for this grant.

ESSER II (CCRA Act): This grant was authorized by the Coronavirus Response and Relief Supplemental Appropriations Act. The time period for funding is March 13, 2020 - September 30, 2023. CUSD 200 is allocated \$4,054,491. During FY21 and FY22, \$3,545,911 has been encumbered for this grant. The remaining funds have been allocated in the following way:

ESSER III (ARP ESSER): This grant was authorized by the American Rescue Plan Act. The time period for funding is March 13, 2022 - September 30, 2024. CUSD is allocated \$9,439,361. During FY22 \$1,973,654 was encumbered from this grant. The following grant allocations have been made for FY23:
