AMENDMENT TO PUPIL TRANSPORTATION SERVICES AGREEMENT

THIS AMENDMENT entered into as of the ____ day of _____ 2022 is made by and between Community Unit School District 200 with principal offices at 130 West Park Avenue, Wheaton, Illinois 60189 hereinafter called “DISTRICT” and SUNRISE SOUTHWEST, LLC, with its local operating address at 1400 West Ogden Avenue, Naperville, Illinois, 60563, hereinafter called “CONTRACTOR”.

WHEREAS, the parties entered into that certain Pupil Transportation Services Agreement dated July 1, 2019,

WHEREAS, the parties desire to extend the term of the Agreement and amend certain portions thereof;

NOW, THEREFORE, the parties mutually agree as follows:

- 1. TERM:** The term of the Agreement shall extend for two (2) additional years commencing July 1, 2022, and continuing through June 30, 2024; thereafter this agreement may be extended on a year-to-year basis by mutual agreement of the parties, subject to the operation of Ill. Rev. Stat. Ch. 105, Sec. 5/29-6.1, as amended from time to time.
- 2. COMPENSATION:** Commencing July 1, 2022, the rates of compensation payable hereunder during the ensuing Contract Years shall be set forth as follows and are based on current number of routes:
 - SY 2022-23: 13% increase of SY 2021-22 rates
 - SY 2023-24: 8% increase of SY 2022-23 rates
 - Current fleet in place for life of contract
- 3. FUEL ESCALATOR:** Commencing July 1, 2022, and for the two-year period of this extension, the fuel escalator clause shall be eliminated.

- 4. LIABILITY INSURANCE:** Commencing on July 1, 2022, and for the two-year period of this extension, the amount of required liability insurance shall be reduced from \$25,000,000 to \$15,000,000.

5. NOTICE TO PARTIES

All notices to be given by the parties to this Agreement shall be in writing and serviced by depositing it in the United States Mail, certified mail.
