Perkins&Will is pleased to submit the following Schematic Design Proposal to Community Unit School District 200 for Monroe, Edison and Franklin Middle Schools Capital Improvement Projects, specifically this proposal is limited to the building additions and some limited renovation scope associated with the interface of the building additions. Terms and Conditions of this proposal are based on the AIA B101-2017, "Standard Form of Agreement Between Owner and Architect", which has completed negotiations and is intended to be approved by the Board of Education at its regularly scheduled June meeting.

The Project team will include Mark Jolicoeur, Managing Principal, Michael Dolter, Senior Project Architect, Steve Turckes, Programming/Planning Principal, and Carl Giometti, Project Architect. Michael Dolter will be the main point of contact with the District for the duration of the effort.

Project Scope

All professional services apply to Monroe, Edison, and Franklin Middle Schools.

Schematic Design represents the first full design phase as defined in the AIA B101 Agreement, Article 3.2. For the purposes of this effort, the design team will focus on developing the proposed building additions, and building upon the initial Conceptual Design. Schematic level technical issues, will be determined in this effort. (Refer to the AIA, B101, Article 3 for a detailed description of Architect's basic services responsibilities.)

The construction budget is based upon the CM's (Nicholas) latest budget, dated May 8th, 2024 as presented to the Board of Education at its meeting the same day.

- Documentation effort will utilize a cloud-based Building Information Modeling (BIM) system, specifically Autodesk Revit 360.
- Additional follow-up user-group meetings will be included as need for additional clarification and/refinement.
- Facilitate weekly meetings with the Administrative leadership team, providing progress updates and opportunity to share feedback.
- Coordinate with CM (Nicholas & Associates) regarding constructability of design intent, (i.e. consideration for building staging), and provide feedback and documents for the CM to develop phase appropriate construction budgeting

Compensation

Schematic Design is a basic service included in the AIA B101 Agreement Between Owner and Architect. Note that the professional service fee indicated below represents a portion of the total Schematic Design Fee as included in Exhibit A of the AIA B101 fee or as included with the project Service Order.

For the scope of services and within the schedule durations described above, Perkins&Will proposes a stipulated sum fee and allowances, as follows:

- \$ 587,147 Schematic Design Professional Services Fee from Mid-June 2024 through early November 2024.
- \$ 99,850 Reimbursable Consultant fees and expenses, (pass-through from P&W to CUSD 200) from Mid-June 2024 through early November 2024.
- \$212,508 Estimated Owner Direct Consulting Fees, (billed direct to CUSD 200) from Mid-June 2024 through early November 2024
- \$ 899,505 Total CUSD 200 Middle School Capital Fee and Expense Investment from Mid-June 2024 through early November 2024

Customary expenses will be reimbursable at cost times a management multiplier of 1.05.
