A meeting of the Human Resources (HR)/Policy Committee of the Board of Education of Community Unit School District 200, DuPage County, Illinois, was called to order at the School Service Center, 130 W Park Ave, Wheaton, IL on Thursday, September 2, 2021, at 1:37 PM.

**Discussion of 2021 PRESS Issue 107**

Dr. Schuler reviewed the status of the policies in PRESS Issue 107. The process includes disseminating the recommended revised policies to the appropriate department for review. Policies are returned with feedback from the Administration to adopt as recommended by PRESS or adopt with changes as recommended by the District.

The policies that were reviewed and discussed by the committee included the following:

- Revised Policy 2:10 – School District Governance
- Revised Policy 2:130 – Board-Superintendent Relationship
- Revised Policy 2:240 – Board Policy Development
- Revised Policy 2:30 – School District Elections
- Revised Policy 5:10 – Equal Employment Opportunity and Minority Recruitment
- Revised Policy 6:145 – Migrant Students
- Revised Policy 6:160 – English Learners
- Revised Policy 6:235 – Access to Electronic Networks
- Revised Policy 6:255 – Assemblies and Ceremonies
- Revised Policy 6:260 – Complaints About Curriculum, Instructional Materials, and Programs
- Revised Policy 7:280 – Communicable and Chronic Infectious Disease
- Revised Policy 8:90 – Parent Organizations and Booster Clubs

There was discussion on the following:

- Policy 6:160 – suggestion to provide a future update to the Board on the District Spanish Bilingual Parent Advisory Committee (BPAC).
- Policy 8:90 – sending the revised policy out to all known District 200 affiliates to ensure compliance.
- Updated policy language vs. updated legal references, footnotes, or five-year review.
- Once the recommended revisions are included in the policy language, they will be included on the Board “policy posting consent agenda”. There are two discussion windows for the Board (posting agenda and approval agenda) and the community has thirty days from posting for public review and to provide comment.
- All of the listed policies will be on the September Board agenda as “approval to post for public review and comment” and on the October Board agenda as “approval of” the policies.

Dr. Schuler noted the upcoming issue of PRESS will be more substantial and is scheduled to arrive this fall. The Board HR/Policy Committee will schedule a meeting once PRESS Issue 108 is received and the policies have been reviewed by the Administration.
