Member Paulsen moved, Member Hanlon, seconded to suspend the rules and adjourn to a workshop setting. Upon a roll call vote being taken the vote was: AYE 7, NAY 0. **The motion carried 7-0**.

## **Welcome and Program**

Dr. Schuler welcomed and thanked everyone for joining today and noted the value of relationships the District has with the collective communities. District 200 Board Members and the leadership team introduced themselves to the group.

Dr. Schuler and members of the District 200 Senior Leadership Team shared information on the District 200 Profile, Finance and Facilities Overviews, the Vision 2026 Strategic Plan, Career Pathways, and SEL (social-emotional learning). All were encouraged to share the information with others in the community. This included information on the following:

- The District 200 "Connect With Us" card provides all of the ways to connect and follow the School District.
- The District profile is updated annually and contains information on:
  - Communities Served
  - Students enrollment and demographics
  - o Facilities total number and by level
  - o Staff licensed, retention, master's or higher percentages
  - o Finance budget, fund balance, S&P bond rating, operating cost per student
  - o Student Opportunities graduate numbers and graduation rate, clubs and athletics, AP classes, college (2 or 4 years), national merit finalists
  - o Technology Center of DuPage (TCD) a proud partnership
  - Vision 2026 Strategic Plan
  - o Social-Emotional Learning
  - o Portrait of a Graduate
  - o Facilities Infrastructure Improvements
- The new strategic plan (Vision 2026) was developed with the support and engagement of the community and contains strategies and tactics that directly align with our Portrait of a Graduate (POG) including academic excellence strategies and operational excellence strategies.
- Career Pathways for HS students— will help high school students to think about what they want to do, this is intentional figuring this out before getting off to college. There are

- sixteen career pathways identified and key components include dual credit college coursework, work-based learning opportunities, and industry-recognized credentials.
- Noted the new Intro to Teaching Class(es) that are part of the Education Pathway.
- Looking to expand the opportunities for dual-credit coursework. The goal is to have students take their entire first year of Gen Ed coursework while in our buildings.
- The learning acceleration strategy highlighted unfinished learning, the adoption of new instructional materials, the MS math pilot, and the ELA pilot at the elementary level.
- Aligning coursework, service and workplace/internship experience for early college opportunities.
- A request if attendees know of any people in the industry that can offer internship opportunities, contact Ian Smith at CUSD 200.
- Finance highlights operating expense per student is second-lowest among five other benchmark districts; fund balance 33.33%; financial recognition designation from the State Board of Education for the last seven years; and the 13<sup>th</sup> consecutive year of running a balanced budget.
- Facilities highlights work done since the 2016-17 facility master plan and developing work plans to work on three of our middle schools; investment of \$45 million on facilities since 2017 (by the end of next summer); the plan for playground replacements.
- SEL focus on the physical and emotional wellness of our students so they can achieve their goals. Noted student connectedness (making sure every one of our students is connected to school and has access to co-curriculars), providing staff professional learning on growth mindset (how it affects and promotes high student expectations) and ensuring students have access to outside care (partnering with a group, Referral GPS, access to thousands of care providers outside of school).
- Monitoring of the plan via the District 200 dashboard (can be accessed from the main page of the website at cusd200.org).

There were comments/questions on the following:

- The ballpark cost of the new Jefferson Early Childhood Center (under \$17 million) and what populations are served there. Ensuring any child 3 and over has access to early intervention. There are just under 300 students at Jefferson.
- Applauding the career pathways in education. What other initiatives does the District have to recruit/retain high-quality educators? Noted the Oct 12 Board Meeting Human Resources report/update, the D200 "grow your own" program, partnering with local universities for student teacher candidates, job fairs, and new interviewstream program.
- COD (College of DuPage) 1+2+1 program will significantly reduce the cost of a college education.
- Commending the Board of Education and the District on how they handled things during the pandemic.

Dr. Schuler and President Crabtree thanked everyone for attending and sharing.
