

**RESOLUTION AUTHORIZING NON-REEMPLOYMENT OF FULL-TIME, FIRST, SECOND, THIRD, AND NON-TENURED TEACHERS**

**WHEREAS**, the full-time teachers hereinafter set forth are completing their first, second or third-year of probationary teaching service during the 2022-2023 school year; and

**WHEREAS**, the Board of Education of Community Unit School District Number 200, DuPage County, Illinois, has determined that the full-time, first, second and third-year, non-tenured teachers hereinafter set forth shall not be reemployed for the 2022-2023 school term, pursuant to Section 5/24-11 of *The Illinois School Code*.

**NOW, THEREFORE**, Be It Resolved by the Board of Education of Community Unit School District Number 200, DuPage County, Illinois, as follows:

**Section 3:** That the President and Secretary of the Board of Education are hereby authorized and directed to send the teachers set forth above a written notice of non-reemployment by certified mail, return receipt requested, at least **forty-five (45) days** before the last day of the school term, which notice shall be substantially as set forth in the Exhibit attached hereto.

**Section 4:** That the Superintendent or his/her designee shall personally deliver, with receipt, a written notice of non-reemployment to the teachers set forth above at least **forty-five (45) days** before the last day of the school term, which notice shall be substantially in the form of the Exhibit attached hereto.

**Section 5:** That this Resolution shall be in full force and effect upon its passage.
