SECOND AMENDMENT TO PUPIL TRANSPORTATION SERVICES AGREEMENT

This AMENDMENT entered into as of the _	day of	2024 is made by and between
Community Unit School District 200 with principal of	offices at 130 V	West Park Avenue, Wheaton, Illinois
60189 hereinafter called "DISTRICT" and SUNRIS	SE SOUTHW	EST, LLC, with its local operating
address at 1400 West Ogden Avenue, Naperville, Illin	ois 60563, here	einafter called "CONTRACTOR".

WHEREAS, the parties entered into that certain Pupil Transportation Services Agreement dated July 1, 2019, which was subsequently extended by an Amendment dated April 13, 2022 ("Agreement").

WHEREAS, the parties desire to extend the term of the Agreement and amend certain portions thereof:

NOW, THEREFORE, the parties mutually agree as follows:

- **1. TERM:** The term of the Agreement shall extend for three (3) additional one (1) year periods for the 2024-2025, 2025-2026, and 2026-2027 school years. Each school year shall commence on July 1st of the given year and continue through June 30th of the following year.
- **2. COMPENSATION:** Commencing July 1, 2024, the rates of the compensation payable hereunder during the ensuing contract years shall be set forth as follows:
 - SY 2024-25: 8.00% increase of SY 2023-24 rates
 - SY 2025-26: 6.00% increase of SY 2024-25 rates
 - SY 2026-27: 5.00% increase of SY 2025-26 rates
 - Current fleet in place for the life of the contract
- **3. FUEL ESCALATOR**: The changes made pursuant to the April 13, 2022 Amendment shall remain in full force and effect.
- **4. LIABILITY INSURANCE:** The changes made pursuant to the April 13, 2022 Amendment shall remain in full force and effect.

5. NOTICE TO PARTIES

All notices to be given to the parties to this Agreement shall be in writing and serviced by depositing it in the United States Mail, certified mail.
