

**RESOLUTION AUTHORIZING NON-REEMPLOYMENT OF FULL-TIME,
FIRST, SECOND, THIRD, AND NON-TENURED TEACHERS**

WHEREAS, the full-time teachers hereinafter set forth are completing their first, second or third-year of probationary teaching service during the 2021-2022 school year; and

Section 3: That the President and Secretary of the Board of Education are hereby authorized and directed to send the teachers set forth above a written notice of non-reemployment by certified mail, return receipt requested, at least **forty-five (45) days** before the last day of the school term, which notice shall be substantially as set forth in the Exhibit attached hereto.

Section 4: That the Superintendent or his/her designee shall personally deliver, with receipt, a written notice of non-reemployment to the teachers set forth above at least **forty-five (45) days** before the last day of the school term, which notice shall be substantially in the form of the Exhibit attached hereto.

Section 5: That this Resolution shall be in full force and effect upon its passage.
